



## TBRI® PRACTITIONER RIGHTS AND RESPONSIBILITIES AGREEMENT: Quick Reference Guide / FAQs

You have been given the title, 'TBRI® Practitioner', by the Karyn Purvis Institute of Child Development at TCU (KP ICD), which comes with various rights and responsibilities for which you will be held accountable. If you are unable to adhere to these responsibilities, the KP ICD has the right to revoke your title and associated rights.

All TBRI® materials you received during the TBRI® Practitioner Training (Phase I and Phase II), and the TBRI® Caregiver Training Package are copyrighted materials and licensed property of the Karyn Purvis Institute of Child Development. As such, you must follow the outlined guidelines for proper use of copyrighted and licensed property. If you are unable to adhere to the guidelines as outlined, the KP ICD has the right to recover any and all licensed property.

### Using copyrighted materials and/or Licensed Property of the KP ICD:

- **If my organization pays for me to attend the TBRI® Practitioner Training, who owns the materials given during *Phase I & Phase II* of the training?**
  - The individual/professional who attends the training is the sole licensee of ALL materials given during Phase I & Phase II of the TBRI® Practitioner Training, regardless of who pays for him/her to attend the training. If the TBRI® Practitioner were to leave the organization that paid for him/her to attend training, all materials given during the training would leave with that TBRI® Practitioner.
- **Can I make copies of/share/sell the materials from *Phase I (online)* of the TBRI® Practitioner Training?**
  - No. All materials used during Phase I of the TBRI® Practitioner Training are licensed/copyrighted materials of the Purvis Institute, and/or are materials that the KP ICD paid copyright fees to use; therefore, you may not duplicate, distribute, or sell any of the materials without express written permission from the KP ICD.
- **Can I use the materials from *Phase I (online)* of the TBRI® Practitioner Training for a research project?**
  - No; not without express written permission from the KP ICD.

- **Can I make copies of/share/sell the materials (handouts/PowerPoint slides/notes, etc.) given during *Phase II* of the TBRI® Practitioner Training?**
  - No. All materials used during Phase II of the TBRI® Practitioner Training are licensed/copyrighted materials of the Purvis Institute, and/or are materials that the KP ICD paid copyright fees to use; therefore, you may not duplicate, distribute, or sell any of the materials without express written permission from the KP ICD.
  
- **Can I use the materials (handouts/PowerPoint slides/notes, etc.) given during *Phase II* of the TBRI® Practitioner Training for a research project?**
  - No; not without express written permission from the KP ICD.
  
- **Can I make copies of/share/sell the *TBRI® Caregiver Training Package*?**
  - No – you may not copy, share, or sell the TBRI® Caregiver Training Package, in whole or in part. The materials that make up the TBRI® Caregiver Training are licensed/copyrighted materials of the Purvis Institute and therefore may not be duplicated, distributed, or sold. The TBRI® Caregiver Training Package cannot be shared (even with other TBRI® Practitioners).
  
- **Can I use the *TBRI® Caregiver Training Package* for a research project?**
  - No; not without express written permission from the KP ICD.

- **Can I use the *TBRI® Caregiver Training Package* when giving a presentation on a related topic (i.e. Attachment theory, Trauma-Informed Care, etc.) outside of my organization?**
  - Yes, BUT you must have KP ICD consent.
- **Can I create, distribute or sell any form of TBRI® derivative work?**
  - No. Derivative works are covered under copyright law and therefore cannot be created, distributed, or sold, other than by the original creator (the Purvis Institute).
  - A derivative work is an expressive creation that includes major copyright-protected elements of an original, previously created first work (the underlying work). The derivative work becomes a second, separate work independent in form from the first.
    - A derivative work can include, but is not limited to, translations, cinematic adaptations, books, video clips, presentations, trainings, workbooks, articles, etc.

Using the trademarked term Trust-Based Relational Intervention® or TBRI®:

- You may **ONLY** use the following terminology in relation to TBRI®:
  - “**Trust-Based Relational Intervention®**” or “**TBRI®**” – the name of the intervention created and taught by the KP ICD.
- **What can I call myself in terms of my TBRI® qualification(s)?**
  - “TBRI® Practitioner” should be the *only* title used when describing your qualification(s) to use, practice, share and/or train TBRI®, after successful completion of the TBRI® Practitioner Training.
    - You may **NOT** use the following terminology in relation to TBRI® when referring to your title/qualification: “KP ICD Staff/Associate/Intern/Fellow”; “TBRI® Certified”; or anything else other than “TBRI® Practitioner”.
    - **\*Exception** – The finite group of professionals who successfully completed the TBRI® Educator Training and given the title ‘TBRI Educator®’ by the KP ICD, can refer to themselves as a TBRI® Educator, knowing that this title allows them the same rights as TBRI® Practitioners who have the TBRI® Caregiver Training Package.
- **What training can professionals attend to become a TBRI® Practitioner?**
  - The “TBRI® Practitioner Training hosted by the Karyn Purvis Institute of Child Development at TCU” is the *only* training that qualifies you as a TBRI® Practitioner upon successful completion.

- **If I use the TBRI® Caregiver Training Package to train others within my organization, what am I allowed to call the training I provide (verbally, in writing, on flyers, for advertising, etc.)?**
  - “TBRI® Caregiver Training” should be the *only* title used to describe the training/presentation you as a TBRI® Practitioner are authorized to use to train others within your organization.
    - You may **NOT** use the following terminology when referring to the TBRI® Caregiver Training you are authorized to provide to others within your organization: “TBRI® Practitioner Training”; “TBRI® Educator Training”; “Train the Trainer Training”; “Hosted by KP ICD”; “Certification Training”; “Certified Training”; or anything else other than “TBRI® Caregiver Training”.

### TBRI® Caregiver Training Package:

- **As a TBRI® Practitioner, can I train others in TBRI®?**
  - Yes, you may use the TBRI® Caregiver Training Package and/or other KP ICD created materials, e.g., videos, books, articles to train staff/clients.
- **How much does the TBRI® Caregiver Training Package cost?**
  - TBRI Practitioner Training 2018 - present
    - Included in cost of the TBRI Practitioner Training
  - TBRI Practitioner Training prior to 2018
    - \$200 (effective 3/5/18)
- **What is required to be eligible to receive and/or purchase the TBRI® Caregiver Training Package?**
  - Successful completion of Phase I and Phase II of the TBRI® Practitioner Training; this includes the Adult Attachment Interview (AAI) done over the phone during Phase I of the training.
  - Signed copy of the TBRI® Practitioner Rights & Responsibilities Agreement form; this must be signed & returned to the Purvis Institute before you can receive the Caregiver Package.
- **Can I complete any outstanding requirements in order to become eligible to receive and/or purchase the TBRI® Caregiver Training Package?**
  - Yes and no. If you did not complete an AAI, you *can* complete one now in order to be eligible.

- **\*Note:** You must complete your AAI by December 31, 2019 to be eligible to receive and/or purchase the Caregiver Package. The KP ICD will not allow any outstanding requirements to be completed after this date.
  - If you did not successfully complete/attend Phase I or Phase II of the TBRI® Practitioner Training you are not eligible to receive and/or purchase the Caregiver Package unless you attend the TBRI® Practitioner Training again. To do this you must apply – find more information at [www.child.tcu.edu](http://www.child.tcu.edu).
- **How do I receive and/or purchase the TBRI® Caregiver Training Package?**
    - TBRI Practitioner Training prior to 2018
      - To purchase, visit [https://epay.tcu.edu/tbri\\_practitioner\\_store/](https://epay.tcu.edu/tbri_practitioner_store/).
      - A username and password are required to log-in to the site; log-in information was emailed to all TBRI® Practitioners once they successfully completed the TBRI® Practitioner Training.  
*\*The username and password are NOT to be shared with anyone.*
      - Once you log-in to the site you will be required to provide your name, organization, job title, and month/year that you attended the TBRI® Practitioner Training.
      - You will be asked to check 2 boxes before your purchase is complete – one stating that you (and any other TBRI® Practitioners you are purchasing for) have successfully completed the requirements to purchase; and two, that you (and any other TBRI® Practitioners you are purchasing for) have read, signed, and returned the Rights & Responsibilities Agreement Form.
      - Once you submit your purchase, the KP ICD will verify that you (and any other TBRI® Practitioners you are purchasing for) have successfully completed the associated requirements (Phase I & II of the TBRI® Practitioner Training, AAI, signed Rights & Responsibilities form) before mailing you the Caregiver Package.
      - The TBRI Caregiver Package is \$200.
    - TBRI Practitioner Training 2018 - present
      - TBRI Caregiver Training Package will be distributed to you on the last day of Phase II, once you have read, signed, and returned the Rights & Responsibilities Agreement Form.
      - The TBRI Caregiver Package cost is included in the price of TBRI Practitioner Training.

- **As a TBRI® Practitioner, can I let my colleagues use the TBRI Caregiver Training Package to train others?**
  - No, the TBRI® Caregiver Training Package cannot be shared (even with other TBRI® Practitioners).
  
- **How do I replace my TBRI® Caregiver Training Package if it gets lost or damaged?**
  - If you damage the flash drive containing your TBRI® Caregiver Training Package you can replace it for a fee of \$100.00.
    - To replace your flash drive please follow these steps:

      - Mail your damaged flash drive to the KP ICD, Attn: Sarah Cronin.
      - Once the damaged flash drive is received, the KP ICD will contact you with payment instructions.
      - Once payment is received, your new flash drive will be mailed to you.
  - If you lose your flash drive containing the TBRI® Caregiver Training Package, contact Sarah Cronin at [s.l.cronin@tcu.edu](mailto:s.l.cronin@tcu.edu) explaining how you lost your flash drive. Once your request is received, the KP ICD will review your request and decide whether or not the flash drive can be replaced.
